The bids will be opened in the presence of Bidder's representatives who choose to attend at **2080-11-29, 13:00 hrs** at the Office of WRIDD Jaleswor, Mahottari bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security which shall be valid for 30 days beyond the validity period of the bid.
